

Rhinebeck Recreation 2017 Summer Hiring

Aquatics Director

Oversees swim lessons and lifeguards, and is present during hours of summer camp to assess campers' swimming levels/abilities for safety. Hours are from 8a-4p Monday-Friday during 7 camp sessions (i.e. weeks). Weekends in June and continues after camp is over. Must have Lifeguard certification (WSI preferable), Lifeguard Management Course certification, and be over the age of 21.

Head Swim Team Coach

Oversees the assistant coaches and assesses the abilities of the swimmers in all age groups. Swim Team is under the DUSO Swim League. Program runs from weekends in June, daily in July, and ends early August.

Assistant Swim Team Coaches

Work with specific age groups under the direction of the Head Coach.

WSI Lifeguards

FT/PT positions available. Instruct in all levels of swim lessons according to American Red Cross Standards. Must have WSI certification and current CPR certification.

Lifeguards

FT/PT positions open from weekends starting Memorial Day then daily beginning June 26 to Labor Day. Must have Lifeguard course certification and current CPR certification.

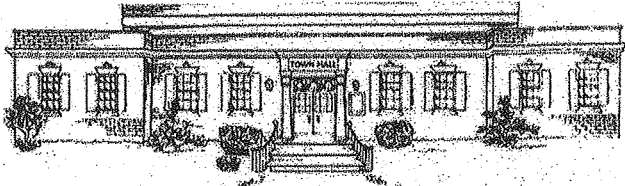
