WAIVER AND HOLD HARMLESS

The undersigned hereby acknowledges that I have voluntarily applied to participate and use the Rhinebeck-Red Hook Dog Park and understand that the acts of unleashing my dog or being physically present inside the Rhinebeck-Red Hook Dog Park necessarily involves risks of injury to me, other people, my dog(s) and other dogs, including but not limited to, risks resulting from aggressive or dangerous dogs, unpredictable behavior, lack of training and lack of vaccination.

The undersigned further hereby releases the Town of Rhinebeck, its officers, employees, servants, agents, sponsors and recognized volunteers from any liability for any injuries sustained or damages incurred and to reimburse the Town for any damages either arising out of or directly or indirectly in connection with the undersigned's use of the Town property and/or facilities. The undersigned hereby further agrees that I will indemnify and hold harmless the Town of Rhinebeck, its officers, employees, servants, agents, sponsors and recognized volunteers from any liability or claims that may result from any use by me and/or my dog of the Town property and/or facilities arising out of this permit.

The undersigned further hereby releases the Town of Red Hook, its officers, employees, servants, agents, sponsors and recognized volunteers from any liability for any injuries sustained or damages incurred and to reimburse the Town for any damages either arising out of or directly or indirectly in connection with the undersigned's use of the Town property and/or facilities. The undersigned hereby further agrees that I will indemnify and hold harmless the Town of Red Hook, its officers, employees, servants, agents, sponsors and recognized volunteers from any liability or claims that may result from any use by me and/or my dog of the property and/or facilities arising out of this permit.

The undersigned agrees to obey the rules of the Rhinebeck-Red Hook Dog Park.

The undersigned represents that any dog listed on the application is at least four (4) months old and has been licensed, de-wormed, vaccinated as required. The undersigned also represents that no dog listed on the application has exhibited aggressive or dangerous behavior and the undersigned has no personal knowledge that said dog (s) has ever bitten another person or dog.
